Waiver, Release, Hold Harmless, and Indemnification Agreement

5. I agree that the participant(s) named, and I shall comply with all stated and customary terms, directions, rules, and verbal instructions for participating in any ride, attraction and/or party with Perelope Croty dba Dry Runners.
